**To make your stay even more enjoyable, we ask you to abide by these few simple rules:**

## safety

- Please observe all warning and information signs located within the park. Children must be advised to stay clear of any boomgates operating in the park.
- Speed limit in the park is strictly 8 km/h or less and pedestrians have 'right-of-way'.
- Be security conscious. Don't share keys, security cards or PIN numbers with anybody. Don't tamper with locks and/or keypads or leave doors to amenity blocks open.
- One lead only to each power outlet.
- 15 amp electrical leads and plugs under current test certification must be used for connection to power supply.
- Note the location of nearest fire hose reel to your site.
- Gas bottles must be under current certification and all gas equipment must be in good operating condition.
- No bikes or skateboards to be ridden once the park lights have come on. All riders must wear approved helmets.
- For environmental and safety reasons, the lighting of fires is not permitted, under any circumstances.
- Playground equipment must not be used between the hours of 8.00 pm and 8.00 am.
- No toxic substances are to be put in any drains.

## conditions of occupancy

- New arrivals and visitors must call at the park reception before entry to the park.
- Payment must be made on arrival for the total period of your stay. No refunds are given on cancellations or early departures.
- Smoking is not permitted in any of the park buildings including public amenities. If smoking occurs in cabins, a cleaning fee will be applied to the account.
- Check-in time from 2.00pm. Check-out time, by 10.00am on day of departure, otherwise a fee will apply. Cabins must be left clean and tidy.
- Extensions and late departures are subject to availability and should be discussed with the park reception as early as possible.

## general points

- All garbage must be wrapped or bagged and placed in the bins provided. Recycling Centres are provided. Please teach children where rubbish goes and what the recycle bins contain.
- Please check message board outside the office for messages.
- Do not leave any valuables outside your cabin/van/ tent day or night, or clothes on the lines for any great length of time.
- Persons causing damage of any type whatsoever to any natural or built asset of the park will be evicted and prosecuted.
- No unreasonable noise at anytime, but particularly after 10.00 pm.
- Trenches are not to be dug without permission of the Manager.
- No responsibility accepted for damage to any vehicles, vans or the contents thereof in the park.
- Parents are responsible for their children's behaviour in the Park and amenities. Children under 8 years must be accompanied to the amenities by an adult.
- Wastewater must be emptied regularly in approved sullage waste disposal points, receptacles must not be allowed to overflow.
- Cars, trailers and other equipment are to be contained on site.
- No cooking or washing of eating utensils is to be done in the park laundries.
- Vans are to be stabilised in an approved manner.
- No clothes lines are to be strung between caravans, annexes or motor vehicles
- Camping in approved areas only.
- No permanent window awnings which may present a safety hazard are permitted.
